THE FOOD PANTRY DISTRIBUTES FOOD 22 HOURS EACH WEEK DURING SHIFTS MONDAY THROUGH THURSDAY. IN FY25 THE FOOD PANTRY EXPERIENCED THE HIGHEST NUMBER OF ANNUAL VISITS AT 23,307. THERE WERE 1,950 SENIOR BAGS DISTRIBUTED. TO SUPPORT CHILDREN WHO ARE AT RISK OF FOOD INSECURITY OVER THE WEEKENDS AND SCHOOL VACATIONS, 11,317 WEEKEND FOOD BAGS WERE DELIVERED TO SCHOOL CHILDREN IN FY25. .
