THE FOOD ASSISTANCE PROGRAMS PROVIDE EMERGENCY FOOD TO THOSE IN NEED THROUGH A PANTRY VISIT OR DELIVERY MONDAY THROUGH FRIDAY. DURING FY21, THE FOOD ASSISTANCE SERVED 2,543 INDIVIDUALS (1,448 HOUSEHOLDS) WITH 589,982 LBS OF FOOD DISTRIBUTED IN 7689 VISITS. DURING FY21, THE SENIOR BAGS WERE DELIVERED TO AN ESTIMATED 575 SENIORS. THE WEEKEND BAG PROGRAM DELIVERED 3,840 BAGS TO SCHOOL CHILDREN THROUGHOUT THE ELEMENTARY AND MIDDLE SCHOOLS IN BEVERLY. THANKSGIVING MEAL INGREDIENTS WERE DISTRIBUTED TO 471 HOUSEHOLDS. THE FOOD ASSISTANCE PROGRAMS HAVE RUN IN A PRE-PACKED BAG FORMAT SINCE MARCH 2020 DUE TO COVID-19.
